KHIGH DHIEGH 1910-1991

Chief among the "Villains We Loved to Hate," he gave us much entertainment with his dynamic portrayal of Wo Fat --a role he obviously enjoyed.

MY BUDDY, WO FAT by Maryann Gallant

Wo Fat appeared in the Five-Ø pilot movie and in the last episode of the series, "Woe to Wo Fat." According to the production numbers, these two shows were actually filmed first and last. Wo Fat appeared in a total of ten episodes after the pilot movie:

Forty Feet High, And it Kills
And a Time to Die...
The Ninety-Second War
Presenting...In the Center Ring...Murder
Nine Dragons

A Bullet for McGarrett
F.O.B. Honolulu (I & II)
The Jinn Who Clears the Way
Murder--Eyes Only
Woe to Wo Fat

In the second and third seasons, he appeared in two separate episodes. In the second season, "Forty Feet High, and It Kills" and "A Bullet for McGarrett." His part in "A Bullet for McGarrett" is so small, however, that many fans forget it in their list of Wo Fat episodes. In the third season, there were "And a Time to Die..." and "F.O.B. Honolulu," a two-part episode.

There were three seasons Wo Fat did not have a single episode-the sixth, tenth, and eleventh seasons. If you don't count "Cocoon" as part of the first season episodes, then you would have to add that season as being a "Fat"-free season.

Out of Wo Fat's ten episodes, he had three season openers: the third season with "And a Time to Die...," the eighth season with "Murder--Eyes Only," and the ninth season with "Nine Dragons."

More on Khigh Dhiegh...

(Gratitude to Maryann Gallant, who called with information from a newspaper article, for much of this item. Other information comes from The Complete Directory to Prime-Time TV Stars, 1946-Prime-Time TV Shows, 1946-Present by Tim Brooks and Earle Marsh.)

Khigh Dhiegh was born in 1910 in Spring Lake, New Jersey, but lived most of his life in New York City. During his life, he wrote eleven books, crafted jewelry, and taught philosophy at the University of California at Los Angeles. He was a follower of the Lichting, and recognized as one of its leading advocates. He owned a Taoist shrine in Tempe, Arizona.

His acting career began when he was "discovered" while working in his mother's New York City book store. A customer asked him if he would like to be in a Broadway play. His acting career led, as we all know, eventually to "Hawaii Five-Ø" where he took on the role of Wo Fat in the pilot movie. In the original script, Wo Fat was killed at the end, but Jack Lord took a liking to the character as a nemesis for McGarrett, and wanted him to reappear in the series.

Khigh Dhiegh had a series of his own, called "Khan," in which he played a private detective who solved crimes with the help of his two children. Khan's daughter Anna was played by Irene Yah-Ling Sun, who appeared in many "Hawaii Five-Ø" episodes, including "Yes, My Deadly Daughter." Also in the cast of "Khan" was Vic Tayback, who played Raymond Parmel in the "Five-Ø" episode "Bones of Contention." "Khan" was canceled after only four weeks on the air (Feb. 7-28, 1975).

Khigh Dhiegh also appeared with Pierce Brosnan in the mini-series "Noble House," based on the James Clavell novel. Another fine performance he gave us was in an ABC-TV movie, "Judge Dee in the Monastery Murders," based on a character created by Robert van Gulick in his retelling of ancient Chinese tales of a fictional judge of the T'ang dynasty.

Khigh Dhiegh died at age 81 of heart and liver failure at Desert Samaritan Hospital. He had been living in Chandler, AZ.

HELEN HAYES AND JAMES MACARTHUR GO TO THE MOVIES

There's a classic-movie series in syndication--"Canterbury Cinema Classics." They run classic movies such as Alfred Hitchcock's "The Lady Vanishes" and other fine films.

The best part is that the series is hosted by Helen Hayes and her son, James ("Book 'em, Danno") MacArthur. He's outgrown cute cuddly Danno; Mr. MacArthur now sports a head of white hair. That doesn't matter--the same soft voice is still there. He does wear an Aloha shirt for the show. He and his mother discuss the movie being aired that week during an informative intermission. It's terrific to see the two of them together.

Independent stations in your area might be the most likely to carry it. It may NOT be listed in your newspaper's listings or in TV Guide under the name "Canterbury Cinema Classics." But phoning around and talking to program directors of your local stations ought to reveal to you if the movie series hosted by Miss Hayes and Mr. MacArthur is being run in your area. And if not, you can ask that they pick it up.

Happy viewing! (Local members note: Jacksonville's Channel 47 runs these films on Sunday afternoons at 1 p.m.)

A "FIVE-Ø" CHRISTMAS TALE... (...or, "Book 'em, Elias!")

[Related by Robert S. Sandla. Mr. Sandla recently retired to Florida after 23 years in Honolulu. He may be seen in the "Hawaii Five-Ø" episodes "And the Horse Jumped Over the Moon," "The Two-Faced Corpse," and "A Jury of One," among others.]

About fourteen years ago, Elias Freij, mayor of Bethlehem (in Israel) was making a fundraising tour of the United States to raise money to repair/expand the parking lot at the Church of the Nativity in Bethlehem, for the tourists. I was named by the Mayor of Honolulu to put together a reception for Mayor Freij, who was accompanied on his tour by a professional fundraiser.

I met with Mayor Freij and his representative, and asked him if there was anything special we could do for him while he was in Honolulu. "Yes," he told me. "There is one thing: I would love to meet Jack Lord!"

It turned out, according to Mayor Freij, that "Hawaii Five- \emptyset " was a favorite show in his strife-torn part of the world. In fact, he told me, when "Hawaii Five- \emptyset " came on, the shooting would stop and everyone would go inside to watch the show!

I called Jack Lord's wife, Marie, and explained the situation to her. The reception was to be held near their home. A couple days later, I received a call from Jack Lord, and he said he'd be happy to meet Mayor Freij. When he appeared at the reception, he brought with him a present for the Mayor--a beautifully-wrought "Hawaii Five-0" badge in a folder, just like they used on the show. Mayor Freij was delighted. He then left for the mainland.

Two weeks later, I received a call from the professional fundraiser, conveying thanks to me and to the Mayor of Honolulu for a wonderful reception. He told me also that Mayor Freij, during the entire tour, proudly displayed his badge identifying him as a member of Hawaii Five-Ø to everyone he met.

THE LATEST ON THE "HAWAII FIVE-0" MOVIE!!

From the Sunday, October $2\emptyset$, 1991, issue of the <u>Los Angeles Times</u> comes this information on the "Hawaii Five- \emptyset " movie in development by Producer Steve Tisch at Hollywood Pictures. (This information was interspersed with comments about several other TV-show-based movies in development.)

"A trip to the movies is <u>supposed</u> to mean a reprieve from television. But a night at the multiplex won't seem much different from a night in the living room, as more and more classic television shows make their way to the big screen.

"The trend is not entirely new: We've had 'Star Trek' and its sequels, 'Dragnet' and 'The Untouchables,' to name a few, but at last count there were more than a dozen projects in development based on hit television shows of the '50s and '60s, including 'The Fugitive,' 'Hawaii Five-0,' 'Mission: Impossible...'

"What is it about TV shows that makes studios want to spend millions to turn them into movies?...

"For one thing, there's the familiarity factor. 'From the studio's point of view, these films are pre-sold,' says Steve Tisch ('Risky Business'), who is developing 'Hawaii Five-Ø' for Hollywood Pictures and has plans for a 'Have Gun, Will Travel' feature. 'The cost of exploiting a movie is so high that a pre-sold idea is an asset.'

"There's also the built-in marketing tool of the old shows' music--usually a theme song already familiar to moviegoers...an executive at Hollywood Pictures already imagines the 'Hawaii Five-Ø' trailer: 'All you need is the theme song and a bunch of action shots.'

"...Producer Tisch describes his 'Hawaii Five-Ø' movie as 'a state-of-the-art cop movie with a lot of special effects and a strong action leading man like Jeff Bridges or Mel Gibson.'"
