IN MEMORIAM

MORTON STEVENS November 11, 1991

Morton Stevens, whom we all know as the composer of the "Hawaii Five-0" theme, died November 11, 1991, of cancer. The Los Angeles Times called the "Hawaii Five-0" theme "among the best-known in television history," but there was more to Morton Stevens's talent. He also composed for such shows as "Police Woman" and "Gunsmoke" as well as for films. He arranged music for John Williams and the Boston Pops, as anyone who listens to the Pops' Saturday-morning broadcasts on public radio knows. He was musical director for concert tours for Sammy Davis, Jr., Dean Martin, Frank Sinatra, and Liza Minnelli.

Member Marsha Goodman, a musician and elementary school teacher, knew Stevens, and writes:

"In July 1990, I called Mort because I was working on an arrangement of the "Hawaii Five-0" theme for flute choir. (The actual score is not available, though there are some (very) simplified piano arrangements on the market.) I told him that I was "taking it off" the episodes; that is, listening to the theme and then writing the music down, one voice (part) at a time. By that time, I had completed an arrangement for flute choir that had ten separate voices, but I was concerned about getting it absolutely perfect. Mort sent me one of his scores right away...."

Marsha attended the memorial service at Stephen Wise Temple in Los Angeles, and noted that Bruce Broughton and Dick deBenedictis, who also composed for "Hawaii Five-Ø," were in attendance, as was Mrs. Leonard Freeman, widow of the creator and executive producer of the series. "At his own request," Marsha says, "only some of his own compositions were played--all very light, nothing somber or morose. ... At the conclusion of the service, the music started up again: It was the 'Five-Ø' theme."

No sad songs for a musician, composer, tutor, mentor, and friend.

THE SAFETY LECTURE

One of our members, Helen Volk, has suggested mention of a safety device on your videotapes. She inadvertently taped over a favorite episode, which brought this to mind. On the edge of a videotape cassette where the label goes, there's a little tab. Take a screwdriver or breadknife (or a fingernail if yours are strong enough!) and simply pop that tab out once you're done recording; then the tape cannot be recorded over and your favorite episode is safe. To re-use a tape with the tab removed, just put a piece of tape over it; remove the tape when done.

THE CASE OF THE HUMBLED DIRECTOR

Another anecdote of "Hawaii Five-Ø" from Bob Sandla.

It seems that 5-Ø was shooting on Ala Wai Boulevard in Waikiki and had traffic botched up. The Mayor of Honolulu, Frank Fasi, came along and demanded of the director that they get off the street (it was rush hour) and to do it right now. The director, unaware this was the Mayor he was talking to, told him to get lost or else he, the director, would have the off-duty policeman (used for traffic control and security) move him on his way. The Mayor then proceeded to tell the director that the policeman worked for him and for the City-County of Honolulu, and if anybody was going to move, it would be 5-Ø.

The Mayor then identified himself to the now panicky director. Result: a formal apology and a bit part in an episode for the Mayor! In "The Two-Faced Corpse," there is a scene where McGarrett is playing golf with a couple other men. Suddenly, Steve gets a flash of insight and leaves the other members of the golfing group flatfooted. One of the men says something like "Steve, where're you going..." and complains that he's been trying to get McGarrett onto the golf course for months. The man reciting that line is Mayor Fasi. Also appearing in that scene as the man holding the flag stick on the green is "Sarge" Kahanamoku, brother of the famous surfer Duke Kahanamoku.

[Note also: in the same episode, Bob Sandla plays one of the cops posing as mobsters to shake up the villain of the piece! -- KR]

COLLECTORS TAKE NOTE -- There's a new price guide to sound-track albums out, and it lists the "Hawaii Five-Ø" album. Two prices appear: 1st edition, 1st pressing (ST-41Ø is the album number), is \$15-\$2Ø. Reissue (SM-41Ø) is valued at \$8-\$1Ø. The album was from Capitol records, released in 1969.

UBIQUITOUS FIVE-Ø

Member Deborah Moen is a police department dispatcher, and she tells us the following:

Did you ever notice McGarrett's radio procedure? I'm a police dispatcher and he would be any dispatcher's worst nightmare! I hope he has his own radio channel and dispatcher. No one else would have a chance to get on the air. We try to get our officers to use their car numbers and be brief. And most importantly to wait to be acknowledged by the dispatcher before they give lookouts or make long transmissions.

When our department started to make a lot of drug busts in the housing projects, the drug dealers were using small children as lookouts. When they saw someone who they believed was an undercover police officer, they would start yelling "Five-0!" Now whenever a police car rides through these areas, everyone in the projects starts yelling, "Five-0!" We even have a police officer who answers the phone in the police station, "McGarrett, Five-0." He's always getting yelled at.

These air horns have an air compressor, five plastic trumpets, and a switch that runs off your car's battery. The horns and compressor mount under the hood of the car. They're loud!

There are nine of the horns left, and Bolles has let us have these \$28 items for less. Now, these nine remaining horns are available to members of the Iolani Palace Irregulars for \$15, including postage (which, considering the whole package weighs six pounds, is a goodly chunk of the price).
