

## A DRIVE BACK INTO TIME

## The 1974 McGarrett Car

R egular readers of the newsletter will recall my article ("Book 'Em") on the 1968 Mercury Parklane I found in Hawaii, and which appears to be the car used on the show from the 1968-69 season through the 1974-75 season. [The article is in issue #34. — Ed.] In that article, originally written a few years ago, I referred to the other car used by McGarrett, a '74 Marquis which replaced my car on the show. In the article, I stated that its fate and whereabouts were unknown, and encouraged enthusiasts to go out and find that car. As many of you know, the car has been located and a few fortunate convention participants got the opportunity to view, ride in and drive this special car!

The car is presently owned by John Nordlum, who is president of the Hawaii Stunt Man's Association and a former stunt double for Jack Lord and Tom Selleck. Rita Ractliffe, Karen Rhodes and myself were fortunate to spend a Saturday morning with John, as he gave us a tour of the island via the McGarrett Mercury.

As John tells the story, at the close of the show in 1980, he approached Lord about the car. Lord cleared the way for John to get title from CBS Television, and John has used the car as his only means of transportation since then. When John got it, the car had approximately 30,000 miles. Presently, it is showing 280,000 and is still capable of pursuing criminals

to swift justice (I confirmed this myself when I got my turn behind the wheel). John has maintained the car during his ownership, and kept the gigantic car in operable condition. The car is not restored by any means, but functions as his everyday driver.

With John's gracious permission, I was able to examine the entire car, as well as all paperwork he had. I was anxious to see what similarities, if any, there were as between his car and mine. Not unepectedly, the glove box was crammed with Jack Lord pictures, similar to baseball cards. (There were no pictures of the car, such as I had found in my glove box). Sixteen years of maintenance receipts showed the usual for a car of this age and mileage.

Digging deeper, I was able to locate the original window sticker as well as warranty information traditionally supplied with the purchase of a new car. The window sticker was fascinating. A normal retail Marquis of this vintage would have a sticker with the Lincoln-Mercury logo at the top, along with Chauncey the Cougar trademark. Not this

one. THe sticker was attributable to Ford Marketing Corporation (whatever that is). A long list of factory options was disclosed, but most interestingly, THERE WAS NO PRICE FOR ANY OPTION OR THE ENTIRE CAR. The delivery dealer was Lynch Lincoln-Mercury of Santa Monica, California (no longer there).

About the car itself: It is a 1974 Mercury Marquis Brougham 4-DR hardtop. Originally, that model sold for \$5,519.00,

base price, and weighed 4,853 pounds. Ford built 4,189 copies but apparently sold only 4,188. This particular car was built in the St. Louis assembly plant on August 31, 1973, and was intended for distribution to the Los Angeles area, apparently as a promotion or marketing tool. The car is equipped with most available factory options, and is powered by a fuel slurping 460 cubic inch V-8. At 280,000 miles, it still has its push, as John let me demonstrate while jumping onto the H-1 freeway during our tour.

John relayed a number of stories about the car, one of which emphasized the perfectionist nature of its first driver. This car was equipped with a silly gimmick known as a Rim-Blow horn which enabled the most

impatient of drivers to merely squeeze the wheel to operate the horn. No need to waste precious time with locating the pad in the center of the wheel. As Lord would exit the car during filming, he would accidentally squeeze the wheel and honk the horn. Not a very dignified appearance for the head of the Hawaiian State Police. The sound technicians would plead with Lord to let it be; they were more than capable of editing out this gaffe. Not Lord, however. He wouldn't tolerate any slip-ups, not even his own. The scenes were always reshot until perfect. The Rim-Blow eventually got the the heave-ho, and a separate switch for the horn was installed on the dash. Another interesting trivia bit is the engraved sign glued to the passenger side of the dash reading in the most strident of terms, "ABSOLUTELY NO SMOKING IN THIS VEHICLE". Eagle-eye viewers can occasionally get a glimpse of the top of this sign while viewing interior shots of the '74. [It's quite visible in "Man in a Steel Frame" when the killer is getting into and out of Steve's car to take out and later replace the fuse in his radio. — Ed.]

So, that's it for now as to the fate of the second car. Someday surely the two cars can be reunited, whether in my home in Chicago or in Honolulu. I shudder to think of the fuel expense for either car, whichever way they go. So next time you see an old black Mercury 4-DR, give a wave and a honk, and see if you can convince the owner to pull just one more end run, for old times' sake. Aloha.

#### **OF SUITS AND SERIES**

A few years ago, there was buzz about a Five-O theatrical film being developed by producer Steve Tisch. That project, which was being done for Hollywood Pictures, an arm of Disney Studios, was killed when Disney Studios got a new head.

There's been much discussion in the press and in cyberspace about a second attempt at a feature film, this one to be produced by George Litto, who used to work with Leonard Freeman, and who was receiving backing from Rose Freeman.

Now that project, too, is in jeopardy.

When Steve Tisch was working on his project three years ago, and there was a great deal of publicity about it, CBS was silent. Now, all of a sudden, they decide that they want to go to court over the rights to the property. In the January 9, 1997, edition of Daily Variety, Adam Sandler reported that CBS was petitioning in federal district court to have the network declared the owner of the rights to the series, and not Mrs. Freeman and her family. CBS claims that Leonard Freeman, as far back as 1966, made contracts which grant them exclusive right to use the characters and premise, and asks damages for "an anticipatd breach of contract."

Why does CBS make this fuss NOW? The reason has been adduced in the entertainment press on the Mainland, in the Honolulu Star-Bulletin in a story the first week in March by Tim Ryan (who attended and covered the Five-O convention), and in a private note to the editor from a source close to the industry. To quote our source, "The reason that CBS is suing George Litto . . . is that they have two made for TV movies in development. One is called Diamond Head, written by John Wilder, which does not look like it is going to go forward. The other project is called Hawaii Five-O, and it is being developed by Steven J. Cannell. They are talking to directors as we speak. This Five-O project will most likely squeeze out the Diamond Head project."

Before I saw this note, before I saw the items in the Mainland entertainment press or in the Star-Bulletin, I commented in the Usenet newsgroup alt.fan.hawaii-five-o that my suspicious nature led me to believe just that — that CBS instituted the lawsuit in order to throw Mr. Litto and Mrs. Freeman on the defensive and clear the way for their new project without them having to render any royalties or other consideration to Mrs. Freeman. Other fans agree with that assessment.

Rumors, of course, abound concerning the series revival. One rumor from the entertainment press states that Jack Lord has been approached and has agreed to make a brief appearance in the pilot for this series, playing the governor. That, according to the Star-Bulletin, is "impossible" and it is much more likely that James MacArthur will appear in that role.

No firm decisions have been made about casting yet.

## **NEW DUES PLAN**

# THAT WAS THE YEAR THAT WAS

A message from Karen Rhodes, editor

Many of you know that for four months, July through November of last year, I was in Seattle, 3000 miles from home, to be a bone marrow donor for my brother, who was ill with a rare disease which often leads to leukemia. Some of you kept in touch via e-mail, and by that became members of my Morale Committee, keeping me sane with jokes, everyday mundane news, and Hawaii Five-O talk.

Others of you wrote me letters (what we computer types call "snail-mail") which also were part of the Morale Committee work. Some of you have written lately expressing the hope that everything went well.

Unfortunately, it didn't. The bone marrow transplant was done, but it was delayed by almost two months by a callous and indifferent insurance company's footdragging. I won't go into boring details, but the delay gave the enemy the time it needed. My brother went into leukemia, and it happened very fast. When he left the hospital, he was given two weeks to live. He was dead in one, on October 17. [Note: since I wrote this, the insurance company, under threat of lawsuit and action from the State of Washington, has agreed to pay all expenses which they had previously ruled not covered.]

My stay, which had originally looked to be maybe a month, turned into four months away from my own family and home, and under tremendous stress. Iolani Palace Irregulars business suffered, too, alas. The newsletters were late; some didn't get them at all. Dues

notices weren't sent out. And when I returned home in November, I had four months of tasks piled up, a yard that was a jungle, and the page proofs of my book to correct and an index to construct for it.

Things are finally settling down, though. If no other emergencies present themselves anytime soon, the newsletters should get back on track. I apologize to those who didn't get theirs (please write and let me know, and I'll send your missing issue or issues), and for all the delays.

I want to say thank you to everyone who kept in touch during this awfully stressful time. Y'all (as we say in the South) are great! Hawaii Five-O fandom no ka oi!

## LEGACY OF TERROR

Episode Summary by Reg Jones

Smooth-talking lawyer Alex Kelsey (Don Porter) helps Mr. Tahashi (C. K. Huang) to finish his last will and testament, then quitely locks him in his room and burns the building down. Kelsey is onto a good thing: The old man headee the Japanese intelligence network on 'Oahu during World War II, and there's strong evidence that he had over a million dollars in gold just before the war began. A message left for his son in a safe deposit box holds the clue to its location. With visions of ingots dancing in his head, Kelsey meets underworld figure Din Lee (Moe Keale) to arrange for the fencing of the gold when he gets his hands on it.

Although Kelsey was Mr. Tahashi's lawyer, he is unable to get access to the safe deposit box. So he awaits the arrival of Tahashi's son Kazuo (Mako). Kazuo immediately goes to McGarrett at Five-O, asserting that his father has been murdered for the gold and claiming that he will be the next victim. Chin Ho is assigned the job of openly tailing Kazuo. While he is waiting outside a bank, one of Kelsey's hired thugs deflates one of Chin's tires. When Kazuo leaves, the hoods follow him while Chin's car wallows to a stop.

When Five-O catches up with Kazuo, he is sporting a lump on his head. His father's secretary is lying dead on the floor. Kazuo explains that the hoods coshed him and then killed her to get an album of photographs which would, in combination with his father's cryptic message, reveal where the gold is buried. Now Kazuo claims he will never find it.

The hoods are picked up and deny any connection with the murder. Shortly thereafter, Kelsey falls from the top of his office building screaming, and untypical behavior for a suicide. Can there be another hand at work? Yes - Kazuo! As unscrupulous as his father was clever, he had earlier obtained the text of his father's message from the secretary, whom he had professed to love. He then got rid of everyone who would have any knowledge of the gold's location. There never was a photo album that held the rest of the clues. Everything was in the message.

In discussing the matter with retired Commander Reginal Blackwell (Lew Ayres), the old man's U.S. intelligence counterpart, McGarrett learns about a broken-down cabin in the hills where the Japanese spy used to go on vacation. Sure that they will find Kazuo there, Five-O descends on the place. Kazuo takes Chin hostage, but is shot from behind by Commander Blackwell, who has surprisingly turned up. Well, not so surprisingly. When the box containing the gold is opened, only three ingots are left. It seems that after the war, old Mr. Tahashi and Commander Blackwell became friends and, in the interest of binding up old wounds, invested the gold in a series of projects designed to help Japanese whose families were suspended between two worlds during the war.

## LEW AYRES, DON PORTER PASS AWAY

Lew Ayres, who played the governor in the original pilot movie for Hawaii Five-O, died in his sleep on December 30, 1996. He was 88 years old. In addition to playing the governor in the pilot, he also appeared in "Legacy of Terror" as Commander Reginald Blackwell, and in "Anybody Can Build a Bomb" as Dr. Elias Haig.

He had a long and distinguished career in movies, though he originally thought movie acting to be a trivial pursuit. "But when I went overseas," he was quoted as saying in 1946, "I changed my mind. I realized how important movies are to the lives of so many people. Why, I even became a fan myself." He starred in All Quiet on the Western Front in 1930 and became, on the big screen, the first celluloid version of Dr. Kildare, playing in several films with Lionel Barrymore in the Dr. Gillespie role later portrayed on television by Raymond Massey.

Don Porter, who played corrupt taxman Jonathan Cavel in "Murder is a Taxing Affair" and corrupt lawyer Alex Kelsey in "Legacy of Terror," died February 11, 1997, in Los Angeles. No cause of death was given. He had a long career in television playing either stuffy bosses or sneaky villains, as well as appearing in more that 200 plays on tour across the U.S. He was 84 years old.

In tribute to both Lew Ayres and Don Porter, this issue's episode summary is "Legacy of Terror."

## **UBIQUITOUS FIVE-O**

"Please let me be the first to point out that Hawaii Five-O plays a significant role in the new feature film Jerry McGuire, starring Tom Cruise. Cruise is watching TV in his hotel room when Five-O comes on — and, not coincidentally, Tom has a sudden change of character, becoming more compassionate toward his fellow man, empathetic, adopting a 'moral high road' approach to life. Not an unusual metamorphosis for anyone who has been exposed to the power of Five-O and Jack Lord. Go see the movie just for this scene. It's awesome!"

#### LATEST ON THE PROPOSED CBS FIVE-O REVIVAL SERIES:

One industry insider tells us that the pilot for the proposed CBS revival of Hawaii Five-O seems to be in trouble. Lead actors have not been decided on yet and three weeks or so after being chosen, the director was fired. This same source also tells us that Dennis Chun, Kam Fong's son and an experienced actor, auditioned for one of the parts and was not chosen. In this insider's words, the producers of the new series "couldn't have cared less about him or his connection to the show. Now having Chin Ho's son avenge his father's death by running for governor would make sense. Too bad."

Another industry insider has a copy of the pilot script, and tells us: "... purists will be spinning in their seats... McGarret [sic] is the governor. Danno is the head of Five-O. The script starts out with McGarrett giving a speech when an assasination attempt is pulled on him. And... Danno is killed. In Danno's absence, two ill-matched detectives are forced to co-head Five-O (the always contrived odd couple scenario). So, that aspect wore on my nerves, and especially when someone on the squad waxes nostalgic and says that if you put the two of them together it equals McGarrett. (NOT).

". . . yes, Chin Ho is brought back from the dead, and Kono and Truck are also brought out of retirement to aid in finding Danno's killer. Ben Kokua and Che Fong (who is described in the script as a retired detective who left the force in 1968) are also brought out of retirement, although they only appear in voice-overs on walkie-talkies.

"The script starts out OK, but DRAGS and is very repetitive in the second act. The third act comes out of nowhere and is SO convenient, as the murder is pinned on a character that is not even introduced until page 43 (out of 60 page script!) which is a page or two before the end of the second act! The last ten pages really suck. I have very little expectation as far as the script being factually correct to the original series, and the fact that so many characters from the original will appear in the pilot (even posthumously) is better than I would have thought. I would prefer to see having good characters, which was one of my favorite things about the original. Unfortunately, the characters in the script look pretty poorly drawn. If there's a good director, he could make them a little more tolerable, but if there's a hack director, they could be SO SO SO cliche and bad. I don't have any word on who the actors are at all yet."

That's all right; neither do the ones doing the show! As for Chin coming back from the dead, one fan asked what part Kam Fong will play, speculating that perhaps his role will be as Chin Ho's ghost. To which another said: "I can see it now: Hey, bruddah! I'm ghost of Five-O Past. You screw this up, I haunt you good, you know?"

Our informant goes on to say about this script for the pilot: "We'll see. This script is dated 2/24/97, so maybe there will be at least ONE revision before they shoot. Just remember how bad Star Trek TNG was the first couple of episodes, but it got better."

But I'm afraid Stephen J. Cannell is no Gene Roddenberry. And certainly he is no Leonard Freeman. [And latest word is that the script is being rewritten; shooting has been delayed to accommodate that.]
